**LATEST INSTRUCTIONS RELATED TO STANDARD OPERATING PROCEDURE (SOP) OF
STUDENTS DURING THE PERIOD OF CONDITIONAL MOVEMENT CONTROL ORDER (PKPB) IN
RAMADAN**

Please be informed that the University through the Student Movement Committee on Campus has agreed to amend some rules specific to students staying on campus as well as students undergoing isolation during the month of Ramadan. The following are the latest instructions:-

A. For students staying on campus

1. The time to enter and leave the campus is set from 7.00 a.m to 11.00 p.m only.
2. The e-hailing service is allowed until 11.00 p.m.
3. Food delivery service is allowed until 6.00 a.m in accordance with the announcement of the National Security Council (MKN).
4. Students are required to have their respective college student movement cards for identification when entering and leaving the campus.
5. For teacher trainees staying at Kolej Datin Sri Endon (KDSE), the existing special procedure remains applicable.

B. For students who are undergoing Isolation

1. Food delivery service is allowed until 6.00 a.m.
2. Compliance with existing Standard Operating Procedure (SOP) is mandatory.

FREQUENTLY ASKED QUESTIONS (FAQ) RELATED TO RAMADAN ON CAMPUS

1.0 Are students still subject to the entry and exit hours of until 10.00 p.m?

No, during the month of Ramadan, the campus entry and exit limits have been extended until 11.00 p.m.

2.0 Until what time can the food delivery service enter the campus?

Food delivery services are allowed on campus until 6.00 a.m, including for students at the isolation centers

3.0 Is it still necessary for a student from a state under the Rehabilitation Movement Control Order (PKPP) to undergo isolation if he/she wants to return to campus?

Yes, all students are required to undergo isolation for ten (10) days including those for states under PKPP, if they want to stay in campus.

4.0 Are female students allowed to pray tarawikh at UTM Mosque?

Yes, female students are allowed to perform tarawikh prayers at UTM Mosque, and they have to comply with the existing Standard Operating Procedures (SOP) that have been set.

5.0 Are students allowed to break their fast at UTM Mosque?

Please be informed that currently the supply of breaking fast food provided by the Islam Center is in limited quantities. Packed food distribution will be made through the Student Residential Colleges only.

6.0 Are students allowed to break their fast en masse at the Laman Menanti (Tasik Ilmu) UTM compound?

Not allowed.

7.0 Is UTM Bazaar Ramadan at Laman Menanti, Taman Tropika UTM open on campus?

No, UTM Bazaar Ramadan is not opened.
