	Answer:	Students are allowed to stay out of campus for a period of not more than 2 hours only.

	Answer:	NOT ALLOWED . All students are required to remain in their respective locality.
7.	Question:	Is the cafeteria/ arcade on campus open during the MCO 3.0 period?
	Answer:	YES . The cafeteria/ arcade will operate from 8:00 am to 8:00 pm according to the guidelines
	7111311-611	set by the University. Dining in the cafeteria (Dine in) is NOT PERMITTED and students can
		only order by take away.
8.	Question:	Is the One-Stop Parcel Center (OPC) open during the MCO3.0 period?
	Answer:	YES . The One-Stop Parcel Center (OPC) will be open as usual according to the set guidelines.
9.	Question:	Are students required to use the MySejahtera application while on campus?
	Answer:	YES . All students must use the MySejahtera application while on campus for the purpose of
		'contact tracing' by the MOH.
		In addition, students also need to check in each time they visit/ enter any premise at the UTM
		campus.

10. Are providers of services such as Reverse Osmosis (RO)Water, Self -Service Laundry and Question: vending machines allowed to enter the campus to restock or perform maintenance? YES. All service providers are allowed to enter and operate as usual in accordance with the Answer: guidelines set by the University. 11. Question: Is food delivery service or daily necessities delivery service (market delivery) allowed to enter the campus? YES. Delivery time is from 8.00 am to 8:00 pm. Answer: 12. Question: Can my parents/ guardians send food supplies or necessities to college? Answer: **NOT ALLOWED**. Parents/ guardians can only send food supplies or necessities to their children/ dependents on campus using food delivery or courier services. 13. Question: Are students allowed to conduct group discussion activities physically on campus? Answer: **NOT ALLOWED**. Group discussion is only allowed online. 14. Question: Am I allowed to go to another room/ college to meet friends during the period of MCO 3.0? Answer: Movement within the campus is **PERMITTED**. However, all group activities are **NOT ALLOWED**. Students are advised to comply with the established SOPs and regulations set by the University. Disciplinary actions will be taken if it is found that students violate the instructions/rules which have been set by the University. 15. Question: Are students allowed to seek treatment at government hospitals or clinics/ private clinics outside campus? YES. Students need to apply through the UTM Health Center (PKU) to obtain the Answer: recommendation of a PKU medical officer before being allowed to get treatment outside. 16. Question: Are students who have a Covid-19 vaccination appointment be allowed to go out of campus? Answer: YES. Permission is given to students who are notified of a Covid-19 Vaccination appointment in Johor Bahru district only. The University will provide transportation for students to the vaccination center. 17. Question: Are students allowed to go out to refuel vehicles for the purpose of movement within the campus? YES. Please refer to FAQ No.5 Answer: 18. Question: Are students allowed to carry out academic research work such as laboratory work / studio? Answer: YES. Only postgraduate students (PG) who are currently on campus and with the permission of Supervisor/Faculty. 19. Question: Are students from outside of campus allowed to come into campus to take things/necessities at the college? Answer: NOT ALLOWED.

Answer: **YES**, provided that the Sports and recreational activities are **performed individually**, **in open**

areas without physical contact and adhering to a physical distancing of at least 2 to 3 meters

subject to the current movement control instructions (SOPs).
