**IMPLEMENTATION OF KAD PRIHATIN SISWA FOR
UNIVERSITI TEKNOLOGI MALAYSIA FULL-TIME STUDENTS YEAR 2022**

Dear students,
Universiti Teknologi Malaysia

The above matter is referred.

2. Please be informed that the University Board of Directors Meeting No. 117 dated 22nd February 2022 has approved the implementation of the Kad Prihatin Siswa initiative which is one of the initiatives of the Ministry of Higher Education (MOHE) and is among the eleven (11) proposals submitted by representatives of the National Student Consultative Council (NSDC) to the National Supreme Leadership during the meeting held on 30th June 2020.

3. The main objectives of the implementation of Kad Prihatin Siswa are to:

- (i) Strengthen and diversify the functions of student matric cards;
- (ii) Facilitate the channeling of allocations or financial aid directly to student accounts;
- (iii) Support the transformation of the IPT financial transaction ecosystem towards campus cashless, and
- (iv) Standardize facilities and offers/ privileges/ rewards/ promotions to IPT students.

4. For a start this move involves only full-time students. Therefore all full-time students of Universiti Teknologi Malaysia are requested to take note on the following matters :

4.1 Student Matric Card

4.1.1 Students need to replace the existing student matric card to Kad Prihatin Siswa. (Dates will be announced)

4.2 Confirmation of Student Consent

4.2.1 Confirmation of Student Consent means that the student agrees to give permission to Universiti Teknologi Malaysia to process and handle the use of personal data of students as per the Personal Data Protection Act 2010 (Act 709).

4.2.2 Students need to respond to the Confirmation of Student Consent through the MyUTM portal via link <https://my.utm.my>.

4.2.3 Students are requested to review the contents of the Confirmation of Student Consent for the change of the Student Matric Card to Kad Prihatin Siswa.

4.2.4 There are no charges or fees to be paid by students.

4.3 Period for the feedback of Student Consent of Kad Prihatin Siswa

4.3.1 Students can respond to the Confirmation of Student Consent for Kad Prihatin Siswa starting from **22nd June 2022 to 5th July 2022**.

5. The effective date starting from the date this Circular is issued.


