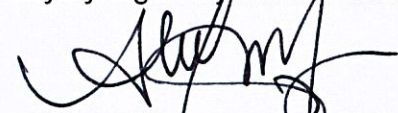

I would like to draw your attention to the above matter.

2. The University would like to remind you on your obligation to:-

- (ii) Students are subject to the Universities and University Colleges Act 1971 (Act 30)

4. The students are prohibited from engaging in any abusive conduct or activities in mental or physical forms towards other students, either within or outside the campus.

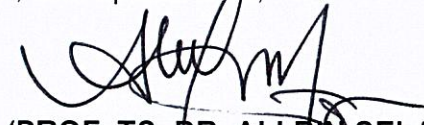

If found guilty the student can be given the maximum penalty of **EXPULSION FROM THE UNIVERSITY.**
