2. 4. Sehubungan dengan itu, semua pelajar adalah **diwajibkan** untuk terus mematuhi peraturan berpakaian tersebut dan adalah diingatkan bahawa mana-mana pelajar yang tidak mematuminya akan menyebabkan beberapa tindakan boleh diambil terhadap saudara/i seperti berikut :-

- (i) **Diberi teguran secara lisan atau bertulis;**
- (ii) **Tidak dibenarkan masuk ke dalam dewan peperiksaan; dan**
- (iii) **Aduan kepada pihak Jabatan Timbalan Naib Canselor (Hal Ehwal Pelajar dan Alumni) untuk tindakan selanjutnya.**



Students are reminded to adhere to the **Student Dress Code** when sitting for the Final Examination Semester I, 2025/2026 Session, under the provisions of **Rule 28 Students' Attire** and **Rule 29, Student Card, Part II, General Discipline, Universities and University Colleges (Universiti Teknologi Malaysia) (Discipline of Students) Rule 2024**.

- (iii) **Will be reported to the Department of Deputy Vice-Chancellor (Student Affairs and Alumni) for further action.**


